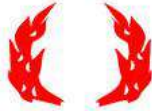

HISTORY

UNIVERSITAS PEMBANGUNAN NASIONAL "VETERAN" JAWA TIMUR

- a. UPN "Veteran" Jawa Timur is one of the higher education institutions in Indonesia founded by Indonesian freedom fighters on July 5, 1959, under the name of the Academy of Corporate Administration "Veteran" (AAPV) Surabaya.
- b. Starting on April 1, 1966 by the Ministry of Transmigration, Veterans Affairs and Demobilization were united in the Jawa Timur Branch of the National Development College (PTPN) "Veteran". On May 17, 1968 the National Development College (PTPN) "Veteran" Jawa Timur Branch expanded into 3 (three) Faculties, namely Economics, Agriculture and Chemical Engineering. Based on the Decree of the Ministry of Transmigration, Veterans Affairs and Demobilization No.062 / Kpts / MENTRANVED / 68 the status of PTPN "Veteran" Jawa Timur Branch became a Service College under the Ministry of Defense Security of the Republic of Indonesia, which then on June 30, 1978 there was a name change to UPN "Veteran" Jawa Timur Branch. Based on the Decree of the Minister of Defense and Security Number: Kep / 01 / II / 1993 dated February 27, 1993 concerning the Arrangement of UPN "Veteran", UPN "Veteran" Jawa Timur Branch, which was originally under UPN "Veteran" Yogyakarta, became independent and led by a Rector so that its name changed to UPN "Veteran" Jawa Timur.
- c. Based on the Joint Decree of the Minister of Education and Culture and the Minister of Defense Number: Kep / 0307 / U / 1994 - 10 / XI / 1994 dated November 29, 1994 concerning the Improvement of UPN Service through the Implementation of Linkage and Commensurate has been transferred its status from official universities to private universities. UPN "Veteran" Jawa Timur since 1993 has 6 Faculties with 17 Departments/Study Programs (Prodi), which have been accredited by National Accreditation Board for Higher Education (BAN-PT).
- d. In accordance with the Instruction of the Minister of Defense and Security Number: Inst/01/II/1996 dated February 6, 1996 concerning the Implementation of the Delegation of Authority and Responsibility for the Development of UPN "Veteran", the guidance has been handed over to the Sudirman Great Commander Championships Foundation (YKPBS) which is located under the Ministry of Defense Jl. Wachid Hasyim No.7 Jakarta, which also fosters the Nusantara Taruna Flagship High School in Magelang.
- e. As of May 1, 2008 UPN "Veteran" Jawa Timur which was originally under the Kejuangan Panglima Besar Sudirman Foundation was transferred to the Education and Housing Welfare Foundation, which is a merger of YKPBS, and Satya Bhakti Pertiwi Foundation with Notarial Deed Imas Fatimah, SH Number: 27 dated August 10, 2007 and Decree Number:

Skep/12/YKPP/2008 dated March 12, 2008 concerning Material Regulations of the Education Implementing Agency.

- f. As of October 6, 2014, UPN "Veteran" Jawa Timur which was originally under the Education and Housing Welfare Foundation with the status of a Private University was returned to a State University with Presidential Regulation number 122 of 2014 consisting of 7 Faculties with 19 undergraduate study programs (S1) and 3 strata 2 (S2) study programs under the guidance of the Ministry of Research, Technology and Higher Education of the Republic of Indonesia with the characteristics of statehood.
- g. Starting from December 6, 2018, UPN "Veteran" Jawa Timur received the status of a Public Service Agency (BLU) based on the Decree of the Minister of Finance of the Republic of Indonesia Number 804/KMK.05/2018.
- h. Starting in 2020, UPN "Veteran" Jawa Timur, which was originally under the guidance of the Ministry of Research, Technology and Higher Education of the Republic of Indonesia, switched to the Ministry of Education and Culture of the Republic of Indonesia.
- i. This development shows that the presence and work of UPN "Veteran" Jawa Timur has been accepted, appreciated, and needed by the community. This development is currently ongoing, through the opening of new study programs, improvement and development of existing fields and education, so that currently UPN "Veteran" Jawa Timur with 8 (eight) Faculties that organize 36 (thirty-six) Study Programs, both at the Diploma (D4), Bachelor Program (S1), Master Program (S2), and doctoral program (S3), which is able to serve more than 20,000 students.

CHAPTER I. GENERAL PROVISIONS

1. Higher Education is the level of education after secondary education which includes undergraduate programs, master programs, doctoral programs, professional programs, specialist programs, and sub-specialist programs organized by universities based on Indonesian culture;
2. The University is the Universitas Pembangunan Nasional "Veteran" Jawa Timur hereinafter referred to as UPN "Veteran" Jawa Timur is a Public Service Agency State University;
3. The Rector is an organ of UPN "Veteran" Jawa Timur who leads the implementation and management of UPN "Veteran" Jawa Timur;
4. The Senate is an organ of UPN "Veteran" Jawa Timur that sets policies, provides consideration, and conducts supervision in the academic field;
5. The Dean is the head of the faculty who is authorized and responsible for the implementation of education in each faculty;
6. The Quality Assurance Group is a university implementing element that assists university leaders in conducting academic quality assurance;
7. Accreditation is recognition of universities or study programs at universities that meet the minimum standards set by the National Accreditation Board for Higher Education (BAN-PT) and the Independent Accreditation Institute (LAM);
8. The institution is a supporting element of UPN "Veteran" Jawa Timur which assists the Rector in carrying out management and administration in accordance with duties and functions;
9. Faculty is a collection of supporting resources that organize and manage academic education in a family of scientific and technological disciplines;
10. The Department is a collection of supporting resources that organize and manage academic education in one field of science, technology, humanities, and arts;
11. Study program is a unity of educational and learning activities that have a certain curriculum and learning methods in one type of academic education and / or professional education;
12. Laboratory is a supporting unit of physical facilities (maximum) for academic implementation in certain fields of science under faculties or institutions;
13. Professor or Professor is the highest functional position for lecturers who are still teaching in higher education units;
14. Lecturers are educators who teach UPN "Veteran" Jawa Timur students;
15. Education Personnel are members of the community who devote themselves and are appointed to support the implementation of Higher Education;
16. Academic Advisor, hereinafter abbreviated as PA, is a lecturer appointed by the faculty to guide and direct students in preparing study plans in

- accordance with applicable regulations, as well as following the progress of student studies that are their supervisor's responsibility;
17. Thesis/final project supervisor is a lecturer appointed by the Dean to guide the preparation of student final project papers;
 18. Students are students at the higher education level at UPN "Veteran" Jawa Timur;
 19. Transfer Students are other College students who transfer to universities or university students who move between study programs within the university;
 20. Students of the Cooperation Program are students from higher education programs outside UPN "Veteran" Jawa Timur who attend learning at UPN "Veteran" Jawa Timur;
 21. Foreign Students are students who are not Indonesian citizens who have received permission from the Directorate General of Higher Education of the Ministry of Education and Culture, Research, and Technology to take part in a non-degree at the university;
 22. Alumni of UPN "Veteran" Jawa Timur are graduates of the Study Program organized by UPN "Veteran" Jawa Timur;
 23. Vocational Education is higher education that prepares students for jobs with certain applied skills;
 24. Academic Education is higher education directed at the mastery and development of branches of Science and Technology;
 25. Foreign students are students at the higher education level at UPN "Veteran" Jawa Timur who come from Foreign Citizens (WNA);
 26. The Semester Credit System, hereinafter abbreviated as SKS, is an education delivery system using semester credit units (SKS), to express student study load, lecturer workload, learning experience and program implementation load;
 27. Curriculum is a set of plans and arrangements regarding graduate learning outcomes, study materials, processes and assessments used as guidelines for the implementation of study programs;
 28. The implementation of learning is learning carried out with a regular system (package system), block system, modules, or other forms determined according to the needs of each vocational study program in meeting learning outcomes;
 29. Lectures are a learning / teaching and learning process which can include direct or indirect communication, practicum, conducting experiments (experiments) and giving other academic assignments;
 30. Graduate Learning Outcomes include 4 (four) domains, namely attitudes, general skills, special skills and knowledge. The formulation of learning outcomes produced must meet the provisions stated in the National Higher Education Standards and the Indonesian National Qualifications Framework;

31. The undergraduate program is academic education intended for graduates of secondary education or equivalent so that they are able to practice science and technology through scientific reasoning;
32. The Indonesian National Qualifications Framework hereinafter abbreviated as KKNI is a competency qualification tiering framework that can juxtapose, equalize and integrate between the field of education and the field of job training and work experience in order to provide recognition of work competencies in accordance with the structure of work in various sectors;
33. *Student Centered Learning*, hereinafter abbreviated as SCL, is a learning system by placing students as the main actors in the learning process and lecturers function as facilitators and motivators;
34. *Sit in* are students who are administratively registered with UPN "Veteran" Jawa Timur, with the main activity of attending lectures, but are not burdened with academic activities consisting of exams, research and other tasks;
35. Credit Earning is an addition to course credits obtained by a student from outside his study program which can be taken both inside and outside UPN "Veteran" Jawa Timur;
36. Credit Transfer *is* the transfer / conversion of credits of courses obtained from outside the study program, which is planned and systematically listed in the curriculum of the study program, which can be taken both inside and outside UPN "Veteran" Jawa Timur;
37. Student Exchange is an exchange activity between UPN "Veteran" Jawa Timur students and other universities both at home and abroad including academic and/or artistic activities based on the agreement of both parties;
38. *Twinning* Program is the development of the same study program between UPN "Veteran" Jawa Timur and universities from within and outside the country by synchronizing the curriculum of the two study programs in order to organize a joint learning process;
39. *Joint Program* is a higher education program that is carried out based on cooperation between faculties or with other universities at home or abroad with the aim of equalization or recognition of the program. Joint Programs can result in degrees from dual programs, which are the result of double degree or joint degree programs;
40. *Double Degree* is a double degree obtained from UPN "Veteran" Jawa Timur and from universities in Indonesia or other universities abroad in the framework of cooperation in the development of a study program and given 2 (two) diplomas;
41. *Joint Degree* is a degree obtained from UPN "Veteran" Jawa Timur with universities in Indonesia or other universities abroad in the framework of cooperation in the development of a study program and given 1 (one) diploma;
42. Study Program Outside the Main Campus of UPN "Veteran" Jawa Timur, hereinafter abbreviated as PSDKU UPN "Veteran" Jawa Timur, is a study

- program held in administrative districts / cities / cities that are not directly adjacent to the main campus of UPN "Veteran" Jawa Timur;
43. Dual status is the position of a student within a certain period of time, having registered status as a student in two or more regular study programs at State Universities (PTN);
 44. Administrative registration is an activity carried out by students to obtain registered status at the university;
 45. Academic registration is the activity of registering as a participant in lectures, practicums, exams and / or other academic activities in the study program by taking courses offered in the semester concerned by filling out the Study Plan (KRS) online;
 46. Study Plan hereinafter abbreviated as KRS is a plan of academic activities that will be carried out by a student during a certain semester;
 47. Semester is a unit of effective learning process for at least 16 (sixteen) weeks including Midterm Exam and Final Semester Exam;
 48. Semester Credit Unit hereinafter abbreviated as SKS is the amount of time for learning activities charged to students per week per semester in the learning process through various forms of learning or the amount of recognition for the success of student efforts in participating in curricular activities in a study program;
 49. Study load is the number of credits that students must take to meet the requirements for obtaining a degree;
 50. Education Program Study Load is the amount of assignment load calculated in credits that must be taken by students to complete a certain level of higher education;
 51. The study period is the limit for completing the study load in following the educational process in the study program;
 52. The Semester Grade Point Average hereinafter abbreviated as IPS is a measure of student academic achievement which is a weighted average score from the scores obtained by students each semester;
 53. The Cumulative Grade Point Average hereinafter abbreviated as IPK is a measure of student ability up to a certain period of time obtained by students;
 54. The Grade Point Average hereinafter abbreviated as IP is the number of multiplications of credit scores with the weighted value of each course divided by the number of credits of courses taken;
 55. Study Results Card hereinafter abbreviated as KHS is a card that contains course grades, Grade Point Average in the current semester and the acquisition of all credits that have been collected and GPA;
 56. Community Engagement Course, hereinafter abbreviated as KKN, is an academic activity in the undergraduate education program that is curricular and interdisciplinary in nature with the aim of identifying and helping solve community problems by prioritizing community empowerment;

57. The final project is a form of scientific work in the form of a thesis or other forms in accordance with applicable regulations, which is one of the graduation requirements for a student determined based on the study program curriculum;
58. Thesis is a task as a learning experience for students to make written scientific papers, and / or projects / prototypes / products based on the results of applied research by integrating attitudes, ways of thinking, and scientific methods in solving applicative problems and being able to present and defend the results in writing and orally and being able to present and defend the results in writing and orally in order to complete a certain study load to obtain a degree bachelor;
59. The Main Supervisor is a permanent lecturer in the study program concerned at the lowest position of expert assistant with a master's degree, who is tasked with leading student guidance in completing the final project or thesis;
60. Accompanying Supervisor is a permanent lecturer in the study program concerned at least an expert assistant with a master's degree who is tasked with assisting the main supervisor in guiding students to complete the final project or thesis;
61. A thesis is an academic paper resulting from in-depth study and/or research that meets the principles of scientific research and disciplinary methodological requirements in order to complete the study load to obtain a master's degree;
62. Research Proposal or Proposal for thesis writing is an academic activity that is planned and prepared according to scientific research principles so that it can be used as a research guideline for a thesis;
63. The proposal exam is an examination of the thesis / thesis research proposal manuscript;
64. Undergraduate Thesis examination is a thesis manuscript exam to meet the requirements for obtaining a bachelor's degree;
65. Thesis Examination is a thesis manuscript exam to meet the requirements for obtaining a master's degree;
66. The Chief Supervisor is a permanent lecturer at least an associate professor with a doctoral degree, who is given the task of leading student guidance in completing a thesis;
67. The Second Supervisor is the assistant lecturer of the Chief Supervisor at least an expert assistant with a doctoral degree, who is given the task of guiding students in completing the thesis;
68. A dissertation is an academic final project resulting from in-depth study and/or research conducted independently and containing new contributions to the development of science and/or finding new answers to problems that are temporarily unknown or questioning various things that are considered established in the fields of science, technology, and art to

- obtain a doctoral degree under the guidance of promoters and co-promoters;
69. Doctoral candidates are the status of doctoral program participants at the Faculty within UPN "Veteran" Jawa Timur who have been declared to have passed the qualification exam;
 70. Promovendus is a term for doctoral candidates who have passed the final examination of the first stage (closed examination);
 71. The promoter is a permanent lecturer of UPN "Veteran" Jawa Timur holding the position of professor / professor or doctoral degree with the position of associate professor and has been the main author in a reputable international scientific journal, who is given the task of guiding doctoral candidates in completing studies;
 72. Co-Promoters are companions of the Promoter, holding the position of professor or professor emeritus or doctor with the lowest position of Lector, who comes from inside or outside UPN "Veteran" Jawa Timur who is given the task of guiding doctoral candidates in completing studies;
 73. Academic Transcript is a list that contains the value of learning outcomes and Grade Point Averages of all courses taken by students during education;
 74. Academic Calendar is an annual schedule of academic activities arranged in detail in each semester;
 75. Single Tuition Fee (UKT) or similar name is a fund that must be paid by students in each semester;
 76. Midterm Evaluation, hereinafter abbreviated as ETS, is an evaluation of student learning held in the middle of the semester;
 77. End of Semester Evaluation, hereinafter abbreviated as EAS, is an evaluation of student learning held at the end of the semester and arranged in the academic calendar;
 78. A valid reason is a reason proven by a valid document for not participating in curricular activities or examinations;
 79. The Judiciary Meeting is a decision-making forum to determine student graduation conducted by the Faculty;
 80. Graduation is an academic event in a university session to inaugurate college graduates who have completed one of the higher education levels;
 81. Judiciary is the graduation determination of a student who has met the curriculum requirements of the study program at the faculty level;
 82. Semester Learning Plan, hereinafter abbreviated as RPS, is a learning process planning determined and developed by lecturers independently or together in a group of expertise in a field of science and / or technology in a study program that contains graduate learning outcomes charged in the course;
 83. Lecture Contract is an agreement between PJMK and students in the implementation of the learning process;

84. Matriculation is an enrichment program in the field of science carried out to improve students' knowledge and abilities;
85. Competency is the accumulation of a person's ability to carry out a job description measurably through a structured assessment, covering aspects of independence and individual responsibility in their field of work;
86. Practicum is a subsystem of lectures which are structured and scheduled activities that provide opportunities for students to gain real experience in order to increase student understanding of theory or so that students master certain skills related to knowledge or a course conducted in the laboratory;
87. Field Work Practice or Practice is a teaching and learning process for students in industry, the business world and the world of work (DUDI), which aims to enable students to apply the knowledge and skills gained in college into the real world of work in accordance with the expertise and competence of Course Learning Outcomes (CPMK) based on the curriculum of each study program;
88. The Merdeka Belajar dan Kampus Merdeka (MB-KM) Program is a learning activity at universities that provides freedom for students to take credits outside the study program for three semesters which can be taken for learning outside the study program within PT and / or learning outside PT. Learning activities outside PT can include student exchanges, internships/work practices, teaching in schools, research/research, humanitarian projects, entrepreneurial activities, and independent projects where all of the above activities must be guided by accompanying lecturers or supervisors.
89. Registration is the registration process for every prospective new student who is declared to have passed the new student admission selection and obtained the right as a student;
90. Registration is the process of re-registering every old student to be able to attend lectures, obtain academic rights and use facilities as a student;
91. Administrative Active is the status of students who have registered/registered and made SOP/UKT payments in accordance with the provisions;
92. Academic Active is the status of students who have registered/registered and made SOP/UKT payments in accordance with the provisions and filled in KRS;
93. Graduation is the status of students who have completed a minimum of credits of the study program curriculum in accordance with the specified time limit and determined through the Judiciary mechanism;
94. Academic Leave is the status of students who are not registered in a particular semester with the permission of the Vice with the approval of the Study Program Coordinator;
95. Resignation is a student status determined by Rector's Decree containing the dismissal of the student based on a proposal from the student or the

- results of an evaluation of study and academic deadlines based on the proposal of the Dean;
96. Academic Resignation is the status of students who are not academically active for more than or equal to two (2) consecutive semesters and determined by Rector's Decree;
 97. Administrative retreat is the status of students who do not register and is determined by Rector's Decree;
 98. Drop Out is a student status determined by Rector's Decree containing the dismissal of the student based on a proposal from the Dean;
 99. The graduation ceremony is a form of academic ceremony held in the open senate meeting forum of the university to induct graduates;
 100. A diploma is a document recognizing learning achievement and/or completion of a higher education level after passing an examination organized by a university;
 101. A competency certificate is a competency recognition document for the achievements of graduates who are in accordance with expertise in their branch of knowledge and / or have achievements outside their study program;
 102. Certificate of Diploma Supplement, hereinafter abbreviated as SKPI, is a document that contains information about academic achievements or qualifications of higher education graduates with degrees;
 103. Certificate in lieu of diploma, certificate of competency, and certificate of profession are declaration documents that are valued equally with diplomas, certificates of competence, and professional certificates.

CHAPTER II. TYPES OF EDUCATION

UPN "Veteran" Jawa Timur carries out academic and vocational education.

2.1 Academic Education

Academic education consists of:

- a. Undergraduate;
- b. Master programs; and
- c. Doctoral program.

2.1.1. Undergraduate

The implementation of Undergraduate Program education is directed at efforts to develop and strengthen students to:

- a. Have intellectuals, and scientists who are ethical, cultured, have the character of State Defense, competent, globally competitive, and able to enter and / or create jobs and able to develop themselves into professionals;
- b. Become graduates with key competencies in accordance with the profile of the study program;
- c. Become graduates who have competencies in accordance with level 6 (six) in KKNI, namely: Demonstrate scientific basics and skills in certain fields of expertise, be able to apply the knowledge and skills they have in accordance with their areas of expertise in productive activities and service to the community, able to behave and behave in presenting themselves to work in their fields of expertise and in living together in the community; and able to follow The development of science and technology which is his expertise.

2.1.2. Master Program

The implementation of Master Program education is directed at efforts to develop and strengthen students to:

1. prepare himself to become intellectuals, and scientists who are ethical, cultured, have the character of State Defense, competent, globally competitive by mastering and understanding, approaches, methods, scientific rules along with their application skills;
2. have the ability to enter and/or create jobs and solve problems in their field of expertise;
3. have the ability to develop oneself into a professional which is demonstrated by formulating a problem-solving approach by means of scientific reasoning or a similar profession;
4. Become graduates with key competencies in accordance with the profile of the study program;
5. As graduates with competencies in accordance with level 8 (eight) in KKNI.

2.1.3. Doctoral Program

The implementation of doctoral program education is directed at efforts to develop and strengthen students to:

- a. Become wiser by increasing ability and independence as philosophers and/or intellectuals, cultured scientists and produce and/or develop theories through comprehensive and accurate research to advance human civilization
- b. Have the ability to manage, lead, and develop research programs; and
- c. Have the ability to have an interdisciplinary approach in working in their field of expertise.

2.2. Vocational Education

Vocational Education is higher education that prepares students for jobs with certain applied skills in the Diploma Four / Applied Bachelor (D-IV) Program. The diploma four graduate program (D-IV) is directed at the results of graduates who have the following qualifications:

- a. Able to apply their field of expertise and utilize science and technology in their fields in solving problems and able to adapt to the situation at hand;
- b. Mastering the theoretical concepts of certain fields of knowledge in general and theoretical concepts of special parts in the field of knowledge in depth, and able to arrange procedural problem solving;
- c. Able to make the right decisions based on information and data analysis, and able to provide guidance in choosing various alternative solutions independently and in groups; and
- d. Able to apply logical, critical, innovative, quality, and measurable thinking in doing specific work in their field of expertise and in accordance with work competency standards in the field concerned;
- e. Able to study cases of the application of science and technology that pay attention to and apply humanities values in accordance with their field of expertise in order to produce *prototypes*, standard procedures, designs or works of art, compile the results of their studies in the form of working papers, design specifications or art essays.

CHAPTER III. COURSES

3.1 Implementation of study programs within UPN "Veteran" Jawa Timur:

- a. Must have an operating permit or have a valid accreditation.
- b. Must have at least 5 (five) permanent lecturers in accordance with applicable regulations.
- c. Must meet quality standards according to the Academic Quality Assurance System.

3.2 The implementation of study programs within UPN "Veteran" Jawa Timur must meet quality standards according to the Academic Quality Assurance System as referred to:

- a. Every study program within UPN "Veteran" Jawa Timur is required to carry out academic quality assurance.
- b. Academic quality assurance includes several dimensions concerning the quality of higher education, namely inputs, processes, outputs and *impacts*.
- c. Quality assurance activities are carried out through the stages of planning, monitoring, internal audit, self-evaluation, correction for continuous quality improvement.
- d. Study programs must have and run quality assurance documents, namely Study Program Specifications, Academic Policies, Academic Standards, Academic Regulations, and Guidelines for implementation procedures.

Study Program can organize programs other than regular classes, namely: cooperation class, International class, *Double Degree / Joint Degree*. International class undergraduate programs can only be held in study programs that organize regular class undergraduate programs accredited A / superior / internationally accredited and get approval from the Academic Senate, ratified and determined by decision of the Rector.

CHAPTER IV. CURRICULUM AND COURSES

The preparation and implementation of the curriculum for all study programs at UPN "Veteran" Jawa Timur refers to the provisions set by the Ministry in charge of higher education affairs. Learning Outcomes of Study Program Graduates consist of:

- a. Attitude;
- b. General skills;
- c. Specific skills; and
- d. Knowledge

The curriculum is designed to produce graduates with competencies that are in accordance with the formulation of minimum learning outcomes, namely the Bachelor and Applied Bachelor Programs equivalent to level 6 (six) qualifications at KKNI, Master Programs equivalent to level 8 (eight) qualifications at KKNI, and Doctoral Programs equivalent to level 9 (nine) qualifications at KKNI;

Curriculum reviews can be conducted in accordance with the development of science, technology, humanities, and arts or evaluated regularly within a period of three to five years by the study program and approved by the faculty senate;

The curriculum is determined in the Decree of the Dean of UPN "Veteran" Jawa Timur after obtaining consideration from the Faculty Senate;

The content and breadth of a course must support the achievement of the scientific vision, mission, and objectives of the Study Program and be measured by credits. A course can be taught by a lecturer or team (*team teaching*) determined by the Dean based on a proposal from the Study Program Coordinator (PPP) / Quality Assurance Group (GPM). Various compulsory learning strategies are developed to achieve Course Learning Outcomes (CPMK);

In the implementation of the learning process, each course must be equipped with a Semester Learning Plan (RPS) and a lecture contract. Each student carries out the learning process / activities referring to the RPS prepared by the lecturer / lecturer team;

The study program through the Study Program Quality Assurance Group conducts evaluation and analysis every semester on the implementation of RPS as part of the implementation of quality assurance.

4.1 Undergraduate

The curriculum structure of the study program at the undergraduate level consists of:

1. Compulsory courses are courses that must be covered in a study program formulated to achieve the main competencies. Compulsory courses consist of national compulsory courses, university compulsory courses, and compulsory courses according to the main competencies of the study program.

National compulsory courses consist of: Religion 2 credits, Pancasila 2

credits, Indonesian 2 credits, Citizenship 2 credits

University compulsory courses consist of: English 3 credits, State Defense 3 credits, Entrepreneurship 3 credits, Leadership 2 credits

2. Elective courses are courses chosen by students from courses inside and / or outside their study program to broaden their horizons and at the same time meet the minimum load requirements of an education level. Elective courses can be: a set of courses contained in other specialization subject groups; A set of courses selected from various other study programs/faculties.

Every undergraduate student is required to pass all courses, both compulsory and elective courses covered in the curriculum structure of the study program;

Each student can choose a combination of:

- a. Compulsory courses and elective courses in the study program; or
- b. Compulsory courses and selected courses from various other Study Programs/Faculties both inside and outside UPN "Veteran" Jawa Timur.
- c. Whatever combination the student chooses, the number of credits that may be taken must be within the study load limit for the Undergraduate Program;

4.2 Master Program

The curriculum structure of the Master Program consists of compulsory courses according to the main competencies of the study program and elective courses that must be followed and included in the calculation of the Grade Point Average. In the event that students take prerequisite courses that are not included in the calculation of the Grade Point Average, the prerequisite courses in question are considered as study load. Master Program students can take courses offered at the master with the status of listener (sit in) without grades and ignored in the calculation of the Grade Point Average;

4.3 Doctoral Program

The curriculum structure and stages of learning can include components: compulsory courses, elective courses, and dissertation supporting courses. The curriculum structure at the dissertation stage includes the following components and loads:

- a. The dissertation component listed in the transcript consists of: a dissertation proposal equivalent to 6 (six) credits and a dissertation equivalent to 24 (twenty-four) credits.
- b. The dissertation component consists of: dissertation seminar, publication, dissertation eligibility (dissertation manuscript), closed dissertation examination (phase I), open examination (stage II), and

other components in accordance with the needs of each study program.

CHAPTER V. ADMINISTRATIVE REGISTRATION AND ACADEMIC REGISTRATION

UPN "Veteran" Jawa Timur students have active status if they have carried out administrative registration and academic registration.

5.1 Administration Registration

Administrative registration is carried out at the beginning of the semester, by paying education fees online through banks that collaborate with UPN "Veteran" Jawa Timur and doing online her-registration at SIAMIK. Student administrative registration can be canceled if it turns out that students are unable to meet the requirements for the learning evaluation stage.

5.2 Academic Registration

Academic registration is carried out by filling out the Study Plan (KRS) through SIAMIK online in accordance with the curriculum applicable to the student.

Some provisions on Academic Registration, namely:

- a. The number of credits that can be taken is adjusted to the IPS (Semester Grade Point Average) in the last semester the student was active.
- b. KRS will not be approved by the academic supervisor if the student takes courses whose course schedule conflicts with other courses, takes courses whose prerequisites have not been met, takes credits exceeding the number of credits allowed;
- c. If the KRS is rejected, the student must correct the KRS and be resubmitted for approval;
- d. The student's name will not be recorded in the list of course participants if the KRS has not been approved;
- e. Students whose names are not listed in the list of course participants are not allowed to take lectures, exams and other activities in the course;
- f. Course replacement can be done by students no later than 1 (one) week after lecture activities begin;
- g. Course cancellation can be done by students no later than the end of the 4th (four) week after lecture activities begin;
- h. Replacement or cancellation of courses must obtain approval from the PA (Academic Advisor);
- i. Students who do not register academically up to 1 (one week) after the lecture activity runs are declared inactive students.

CHAPTER VI. LEARNING METHODS AND FORMS

6.1 Learning Methods

Learning methods applied to the implementation of learning are interactive, holistic, integrative, scientific, contextual, thematic, effective, collaborative, and student-centered, namely:

- a. Interactive, prioritizing the two-way interaction process between students and lecturers;
- b. Holistic is the formation of a comprehensive and broad mindset by internalizing local and national excellence and wisdom;
- c. Integrative is an interdisciplinary and multidisciplinary approach;
- d. Scientific is to prioritize a scientific approach so as to create an academic environment based on a system of values, norms, and rules of science and uphold religious and national values;
- e. Contextual is the ability to solve problems in the realm of expertise;
- f. Thematic is learning that is adapted to the scientific characteristics of the Study Program and is associated with real problems through a transdisciplinary approach;
- g. Effective is successful learning by prioritizing the internalization of material properly and correctly within an optimal period of time;
- h. Collaborative is shared learning that involves interaction between individual learners to produce capitalization of attitudes, knowledge, and skills;
- i. Student-centered is learning that prioritizes the development of students' creativity, capacity, personality, and needs, as well as developing independence in seeking and finding knowledge.

The implementation of the learning process is prioritized by the *Student Centered Learning (SCL)* method, including problem-based learning / case-based learning, project-based learning (project-based learning); interactive skills (group discussions, role plays and simulations); Collaborative learning, cooperative learning or other effective learning methods help fulfill graduate learning outcomes.

Each course may use one or a combination of several learning methods;

- a. The form of learning carried out can be in the form of lectures, responses, tutorials, seminars, practicums, studio practices, workshop practices, field practices, work practices, research, design, and community service.

6.2 Forms of Learning

The form of learning carried out can be in the form of lectures, responses, tutorials, seminars, practicums, studio practices, workshop practices, field practices, work practices, research, design, and community service.

The form of learning can be done within the Study Program and outside the Study Program.

The form of learning outside the Study Program is a learning process consisting of:

- a. Learning in other Study Programs at the same University;
- b. Learning in the same Study Program at different universities;
- c. Learning in other Study Programs at different Universities; and
- d. Learning at *non-tertiary institutions*.

The forms of learning activities outside the Study Program are:

- a. Student exchange activities in taking courses;
- b. Internship/Work Practice;
- c. Village/KKN-Thematic Projects
- d. Research
- e. Entrepreneurial Activities
- f. Independent Project Study
- g. Humanitarian Projects
- h. Teaching in Schools/Education Units
- i. Backup Components

The Learning Process for forms of learning outside the Study Program is carried out based on a cooperation agreement / MoU between Higher Education and Higher Education or other related institutions, or activities in the program determined by the Ministry and / or leaders of Higher Education;

- a. The results of learning activities outside the Study Program as referred to in paragraph (4) are recognized through the credit transfer mechanism (*Credit Transfer*) or credit acquisition (*Earning Credit*);
- b. Learning Activities outside the Study Program as referred to in paragraph (4) are carried out under the guidance of lecturers;
- c. The learning process outside the Study Program as referred to in paragraph (1) is carried out at least after students take 3 semesters, except for the Freedom to Learn Programs-Independent Campus (MBKM) which is determined by the Ministry of requirements.

CHAPTER VII. LOAD AND PERIOD OF STUDY

7.1 Determination of Study Value and Load

The amount of student study load in a course is expressed in a unit of value, called the Semester Credit System (SKS). The study load is applied in the form of a credit system that aims to provide opportunities for students to be able to choose certain academic / professional / expertise level programs in accordance with the needs and demands of development through planning learning activities every semester. In addition, the credit system will provide opportunities for students who are capable and study hard, can complete their studies in a relatively short time, according to their abilities and individual plans. The implementation of the credit system is also expected to facilitate curriculum adjustments from time to time, in accordance with the development of science and technology as well as changes in community needs;

Based on Permendikbud Number 03 of 2020, the determination of the value and burden of one credit unit for semester 1 (one) credit, is as follows:

1. The learning process in the form of lectures, responses, or tutorials consists of:
 - a. For Students
 - 1) 50 minutes of scheduled face-to-face events with lecturers, for example in the form of lectures;
 - 2) 60 minutes of structured academic activities, namely study activities that are not scheduled but planned by lecturers, for example in the form of making homework or solving questions and case studies;
 - 3) 60 minutes of independent academic activities, which are activities that must be carried out by students independently to explore, prepare or other purposes of an academic task, for example in the form of reading reference books.
 - b. For Educators (Lecturers)
 - 1) 50 minutes of scheduled face-to-face events with students;
 - 2) 60-minute structured academic activity planning and evaluation event;
 - 3) 60 minutes of course material development.
2. The learning process in the form of seminars and other similar forms consists of:
 - a. Face-to-face activities of 100 (one hundred) minutes per week per semester; and
 - b. Independent activities 70 (seventy) minutes per week, per semester.

3. The learning process is in the form of practicum, research, fieldwork practice and the like;
4. One semester credit (SKS) in the form of practicum learning, studio practice, workshop practice, field practice, research, community service, and / or other equivalent forms of learning, is 170 (one hundred and seventy) minutes per week per semester, or equivalent stipulated by Permendikbud Number 03 of 2020 in the implementation of Freedom to Learn;
5. The calculation of learning load in a block system, module, or other forms is determined according to the needs in meeting learning outcomes, compiled in the relevant faculty education guide;
6. Calculation of the learning load of the Independent Campus Learning Activities (MBKM) in accordance with the guidebook set by the faculty or study program;

7.2 Fulfillment of Study Period and Load

The fulfillment of the study period and load for undergraduate students or applied undergraduate programs can be carried out by:

- a. Follow the entire learning process in the Study Program at Higher Education according to the period and study load; or
- b. Follow the learning process within the Study Program to meet part of the study period and load and the rest follow the Learning process outside the Study Program, inside or outside the University.

High-achieving students are students who have a semester Grade Point Average (IPS) greater than 3.0 and meet academic ethics. The amount of study load in the following semester, expressed in the number of credits that may be taken in each semester, is based on the Prestration Index (IP) in the previous semester, with the provisions in Table 7.1.

For new undergraduate and applied undergraduate students, the study load for one year (semesters 1 and 2) the number of credits that can be taken by the package system in Semester I is 20 credits and a maximum of 22 credits in Semester II. after 2 (two) semesters in the first academic year, students can take a maximum of 24 (twenty-four) credits per semester in the following semester if they have high academic achievement, while the

fulfillment of the study period and load for master and doctoral program students is carried out by following the entire learning process in the Study Program at Higher Education according to the study period and load;

The study load of educational programs is divided based on the levels: Diploma Four (D-IV), Bachelor (S-1), Profession, Master (S-2), Doctoral (S-3). The study load that must be taken to complete the higher education level is calculated in units of credits. The study period is a scheduled study time that must be taken by students in accordance with the required time span. The study load and study period of diploma, bachelor, master and doctoral programs are described in Table 7.2.

Students must be able to complete the study period on time according to the time frame required to obtain the National Diploma Numbering. Students can complete the study period before the study period on time provided that they have taken the specified study load;

Students who have not completed their studies until the study time on time will receive a warning letter for the study deadline, as described in Table 7.3.

7.3 Drop out of studies

A student is declared to have dropped out of study (DO) if the student does not meet the academic requirements within the limit of study period / length of study according to applicable regulations. The student is not allowed to continue his studies and must leave the Faculty or Study Program.

7.3.1 Undergraduate

- 1) Things that cause dropout of study (DO) for undergraduate programs or applied sajana (S-1) are:
 - a) Exceeding the maximum study period limit.
For UPN Veteran Jawa Timur students who have exceeded their study period (more than 7 years) are subject to DO sanctions.
 - b) Not reaching the minimum number of credits within certain study period limits as follows:
 - (1) At the end of 4 (four) semesters have not been able to collect at least 36 credits and GPA less than 2.00. In the event that the number of credits obtained is more than 36 credits and the GPA is less than 2.00, the calculation of GPA is based on courses with the best value of 36 credits;
 - (2) At the end of semester 8 (eight) students have not been able to accumulate at least 110 credits and GPA less than 2.00. In the event that the number of credits obtained is more than 110 credits and the GPA is less than 2.00, the

calculation of GPA is based on courses with the best value of 110 credits.

2) DO Sanction Procedure

- a) If students in the first semester have a social studies of less than 2.00 will be given a warning I by the Study Program Coordinator in writing, a copy to the Academic Advisor, Dean and Parents/Guardians;
- b) If students in the second semester have a fixed GPA of less than 2.00 will be given a warning II by the Study Program Coordinator in writing a copy to the Academic Advisor, Dean and Parent/Guardian;
- c) If the Student in the third semester has a GPA of less than 2.00 will be given a warning III by the Study Program Coordinator in writing a copy to the Academic Advisor, Dean and Parent/Guardian;
- d) If at the end of semester IV you have not been able to collect at least 36 credits with a GPA of <2.00 or in semester VIII you have not been able to collect at least 110 credits with a GPA of <2.00 or after 7 years have not graduated from undergraduate, you will be sanctioned by DO;
- e) Sanctions are given in writing by the Rector, at the proposal of the Dean of the Faculty.

7.3.2 Master Program

Students participating in the Master Program are declared to have dropped out of their studies if:

- a. Students for academic, administrative, health, and/or other reasons of their own volition to resign;
- b. In the event that students are unable to meet academic requirements in accordance with applicable regulations;

The drop out of studies is determined by the Rector on the proposal of the Dean based on a judicial meeting at the Faculty level;

Students who are declared to have dropped out of their studies for academic, administrative, health, and/or other reasons of their own volition can be given a certificate and academic transcript issued by the Dean / Directorate of PAscasarjana (Graduate Director);

7.3.3 Doctoral Program

Students participating in the Doktor program are declared to have dropped out of their studies if:

- a. Exceeding the study deadline of 7 (seven) years or 14 semesters;
- b. Inactive for 2 consecutive semesters;

- c. Declared not to meet the eligibility to continue studies on the basis of consideration of health tests (physical and mental) from a team of doctors appointed by the university;
- d. Obtain sanctions for gross academic violations;
- e. Get a court decision that has permanent legal force with a sentence of at least 2 semesters.

Doctoral Program students who drop out of study due to factors exceeding the study deadline of 7 (seven) years or 14 semesters and are inactive for 2 consecutive semesters, may:

- a. Submit a letter of application for resignation approved by the sponsor/assignor, known to the academic supervisor/study program coordinator addressed to the Dean / Director of Postgraduate;
- b. The Dean / Director of Postgraduate submitted a letter of application to the Rector to be issued a Decree of the Rector of UPN "Veteran" Jawa Timur regarding resignation;
- c. The Rector, based on the proposal of the Dean / Director of Postgraduates, issues the Rector's Decree on resignation;
- d. If within no later than 2 months since it is declared unfit to continue studying, the student concerned does not apply for resignation, then the Rector issues a Decree of the Rector of UPN "Veteran" Jawa Timur regarding terminating the study relationship.

Doctoral Program students who drop out of their studies due to factors are declared ineligible to continue their studies on the basis of consideration of health tests (physical and mental) from a team of doctors appointed by the university, and get sanctions for serious academic violations, then:

- a. Within 1 month at the latest after the decision of the UPN "Veteran" Jawa Timur legal team as stated in the UPN "Veteran" Jawa Timur Rector's Decree or court decision is issued, the Dean / Director of Postgraduate submits an application to the Rector to issue a Decree of the Rector of UPN "Veteran" Jawa Timur regarding dropping out of studies;
- b. The Rector, based on a proposal from the Dean / Director of Postgraduate, issued the Decree of the Rector of UPN "Veteran" Jawa Timur regarding the termination of study relations

CHAPTER VIII. ASSESSMENT AND EVALUATION OF STUDY RESULTS

8.1 Objectives and ways of assessment of study results

Assessment and evaluation of study results aims to:

- 1) Assess whether students have understood or mastered the subject matter that has been conveyed in the lecture;
- 2) Grouping students into several groups based on ability;
- 3) Assess whether the learning outcomes of the courses delivered are in accordance with the Higher Education Curriculum (KPT);
- 4) Knowing whether the way lecturers are presented in the teaching and learning process is good and as feedback for lecturers for further improvement.

How to evaluate by conducting Midterm Evaluation (ETS) & End of Semester Evaluation (EAS) and can be with other evaluation methods set by course lecturers in the Semester Learning Plan (RPS).

Midterm Evaluation (ETS) and End of Semester Evaluation (EAS)

- 1) Midterm Evaluation is held after completion of discussion of several subjects in accordance with the Semester Learning Plan (RPS);
- 2) The End of Semester Evaluation is held after all lecture materials are given in the semester;
- 3) Evaluation can be carried out in the form of written examinations, oral examinations, seminar exams, presentations, according to the type of course and in accordance with the learning outcomes, which are outlined in the course RPS .

8.2 Implementation and Assessment of Evaluation

Implementation of evaluation by taking into account, the following:

- 1) Midterm Evaluation and End of Semester Evaluation are held according to the academic calendar. The exam schedule is announced along with the announcement of the lecture schedule;
- 2) Students who are hit by a disaster so that they cannot take part in midterm evaluations, end-of-semester evaluations or other academic tasks, will get a grade / K mark (incomplete) on KHS. This K grade must be corrected by students before the next semester's KRS filling period. If not corrected, the K value will be converted to the E value in KHS;
- 3) Courses whose grades are late submitted by the lecturer concerned will be marked I in KHS;
- 4) Each student is allowed to take the final semester examination of a course if the student attends at least 90% of the lecture activities during 1 (one) semester.

Assessment Evaluation has the following references:

- 1) Assessment Guidelines
Success assessment guidelines are expressed in the form of letters **A**, **A-**, **B+**, **B**, **B-**, **C+**, **C**, **D+** , **D**, and **E**.
- 2) Assessment Composition .
The composition of the study given to a student will be contained / included in the lecture contract / Faculty Manual. The composition of the assessment includes 5 activities, namely: UTS, UAS, Quizzes, Structured Assignments and Attitudes. The weighting of each activity depends on its learning outcomes. Special Attitude allocated 20%.
- 3) Assessment Reference
The reference for the assessment of a course can be carried out according to the Benchmark Reference Assessment (PAP), the reference for the PAP assessment is mainly imposed on courses that **include Cognitive, Affective and Psychomotor aspects** in accordance with **predetermined** learning outcomes.
- 4) Assessment techniques consist of observation, participation, performance, written tests, oral tests and questionnaires.

Table 8.1 explains the number values, grades in letter form and the assessment weights for each course

8.3 Learning Outcomes Assessment

Assessment of success is expressed by Semester Grade Point Average (IPS) and Grade Point Average (GPA). The grade point average is the average score for the courses a student has taken. The Semester Grade Point Average

shows the success of students in participating in educational programs in a semester, while the Cumulative Grade Point Average is the average result of all Grade Point Averages that have been achieved in the semester that has been attended by the student concerned cumulatively.

The amount of IPS and GPA can be calculated as follows:

$$IPS = \frac{\sum (Ks \times N)}{\sum Ks} \quad IPK = \frac{\sum (Kk \times N)}{\sum Kk}$$

provided that:

- Ks = the number of credits of courses taken in that semester;
- Kk = number of credits of courses that have been taken since the beginning until the semester in question without failing grades (grade letter E);
- N = the weighted value of each Course.

Based on the social studies obtained in the last semester, the study load can be calculated in the following semester, with the provisions set by the Dean of the Faculty.

Examples of IPS-related calculations are described in Table 8.2.

8.4 Monitoring and Evaluation of Study Results

Monitoring and evaluation of study results on students covers two areas, namely evaluation of the success of managing academic activity events and evaluation of student success in participating in overall academic activities.

1. Evaluation of the success of managing academic activity events
 - Evaluation of the success of event management activities is carried out at the end of each semester and includes three aspects, namely:
 - a. Programmatic activity evaluation.
 - b. Evaluation of the readiness of academic support facilities (laboratories and teaching media aids)

c. Evaluation of learning outcomes.

This evaluation is carried out together with all other evaluation results as consideration for filling in academic activities for the next semester. Evaluation of student success is intended to obtain information or data about:

- a. The number of study loads successfully completed in the semester concerned and previous semesters.
- b. Student success scores;
- c. Semester grade point average (IPS) and grade point average (GPA);
- d. The relative standing of a student in his class as well as the average grade.

Evaluation of student success in each semester can be seen in the Semester Grade List at KHS which lists success scores, Semester Grade Point Average and Cumulative Grade Point Average.

2. Evaluation of student success in participating in overall academic activities

The overall evaluation of academic activities is intended to evaluate students who have completed their study load. Students who are declared to have completed their study program are entitled to a Bachelor degree from UPN "Veteran" Jawa Timur. Students *are declared to have completed their study program if they have met the following requirements:*

- a. Accumulate at least the *minimum number of credits* as specified in the curriculum;
- b. Achieve a *Grade Point Average* greater than or equal to 2.00 (two point zero zero);
- c. The minimum grade of the courses taken is C (2.00), so there is no grade D or E;
- d. Have carried out KKN, KKP / Internship / PKL, for S-1 and D-4 Undergraduate Programs;
- e. Have completed the final project / thesis / thesis / dissertation required for students;
- f. Have passed the oral examination in the bachelor/master/doctoral session;
- g. Have revised the thesis / final project / thesis / dissertation from the results of the Examination Session;
- h. Do not have UKT or other bills;
- i. Free from borrowing Libraries and Laboratories;
- j. Have published scientific articles

In accordance with Permendikbud number 03 of 2020, students who have been declared graduated, will get a predicate as described in Table 8.3.

CHAPTER IX. ACADEMIC LEAVE

Academic leave is a release from students from the obligation to participate in academic activities for a certain period of time and is not counted in the study period.

- a. Academic leave requirements are:
 - 1) Registered as a student;
 - 2) Already have a Student Identification Number (NPM);
 - 3) Have attended an education program for at least 2 (two) consecutive semesters for the first time academic leave, unless there is a strong and unavoidable reason (eg serious illness);
 - 4) Submit written reasons that can be approved/accepted by the Faculty Leader.
- b. Procedures for academic leave are regulated as follows:
 - 1) Students apply for academic leave to the Rector cq Warek I known to the student's parents, Academic Advisor, Study Program Coordinator and Dean accompanied by a photocopy of the full payment of previous study fees, a certificate about free book loans, laboratory equipment, transcripts, and proof of the reason for leave;
 - 2) The deadline for submitting applications for academic leave is in **the first week of the** beginning of the gasal/even semester.
- c. Implementation of academic leave
 - 1) Academic leave is only granted for 1 (one) semester, and if the leave is again the procedure in points 3.10 a and b. must be fulfilled;
 - 2) Academic leave is only permitted for a maximum of 2 (two) consecutive semesters.
- d. Conditions during academic leave
 - 1) Obligated to return the student card at the time of applying for leave;
 - 2) The student is not allowed to participate in all learning activities during academic leave;
 - 3) The value of courses that have been passed and the number of credits that have been obtained remain valid;
 - 4) The period of academic leave is not taken into account in the period of study;

CHAPTER X. JUDICIARY AND GRADUATION

10.1 Judicium

Student graduation is declared through the determination of graduation at the faculty. The determination of graduation is held through the judiciary at the faculty level. Students are declared graduated if they meet the following requirements:

- a. Have passed the final project / thesis / thesis / dissertation examination in front of the examiner or examination team;
- b. Have submitted a revision of the final project / thesis / thesis / dissertation that passes the detection of anti-plagiarism with certain applications. Students are required to retake the exam, if they do not submit revisions within 1 month of the exam;
- c. Status as an active student in that semester and does not exceed the maximum study period set by the university;
- d. Complete all administrative obligations including returning all borrowed library/laboratory collections;
- e. Have completed all obligations within the study period and/or assignments charged in accordance with the curriculum set for the study program;
- f. Have uploaded the final project/thesis/thesis/dissertation on the UPN "Veteran" Jawa Timur repository;
- g. Have articles from the final project / thesis / thesis / dissertation that have been published in scientific journals recognized by the Study Program:
 - Bachelor Program: at least in an accredited national journal as the first author with *accepted/published status*;
 - Master Program: at least in national scientific journals accredited by SINTA 1-4, reputable international journals or proceedings indexed by Scopus from *international conferences*;
 - Doctoral Program: at least in reputable international journals indexed with $SJR \leq 0.1$ and / or $JIF \leq 0.05$.

10.2 Graduation

Graduation is a formal inauguration process for graduating students who have studied, both S-1, S-2 and S-3 at a university. Undergraduate graduation at UPN "Veteran" Jawa Timur is held 3 times in 1 (one) academic year, namely at the end of the semester (October), the beginning of the even semester (February) and at the end of the even semester (July). Graduation was held in an Open Meeting of the University Senate.

Students who have been declared graduated from undergraduate, master, and doctoral education at UPN "Veteran" Jawa Timur are required to attend the graduation ceremony during their graduation period, or no later

than 1 (one) subsequent graduation period since being declared graduated. Students who have not attended graduation, then students cannot get the original diploma and transcript. All students who have been declared graduated will get a diploma, academic transcripts and congratulations from the Rector, while specifically for Bachelor Program students will get SKPI documents.

10.3 Best and Outstanding Graduates

The awarding of graduates within UPN "Veteran" Jawa Timur aims to:

1. Encourage the improvement of the quality of student services and student activities at the local, regional, national and international levels.
2. Fostering student awareness in developing interests, talents, reasoning and creativity as well as improving student welfare and entrepreneurial development.

This has an impact on the benefits: improving the quality of graduates and increasing competitive advantage within the Universitas Pembangunan Nasional "Veteran" Jawa Timur;

Graduates who are included in the best graduate assessment criteria are (1) have a GPA equal to or more than 3.50, and a maximum study period of 4 years;

Further determination of the assessment of the best graduates is based on four criteria, namely: Cumulative Grade Point Average with a weight of 60%, study period with a weight of 20%, Off-Campus MBKM Activities with a weight of 10%, and Championship Achievement with a weight of 10%;

Outstanding graduates are determined based on the highest achievement criteria accumulatively while they are UPN "Veteran" Jawa Timur students which refer to SKPM regulations, covering the fields of science, technology, law, humanities, sports, cultural arts at the national / international level;

10.4 Graduation Cancellation

Graduates who commit plagiarism in the preparation of works will eventually have their graduation canceled. Graduates who have cancelled their graduation are required to rearrange their final work. Graduates who do not carry out their obligations as stipulated, will be subject to sanctions for revocation of academic degrees;

10.5 Diploma and KTM Replacement

1. For alumni, if the original diploma is damaged or lost, a certificate in lieu of the diploma will be issued;
2. If there is an error in writing the diploma, a certificate of improvement in writing the diploma will be issued;
3. The issuance of a certificate in lieu of a diploma and a certificate of improvement in writing a diploma submitted by alumni to the rector at the request of the owner of the diploma equipped with strong evidence;
4. KTM is a Student Identity Card issued by the Academic and Student Affairs Bureau for Applied Undergraduate, Undergraduate, Master and Doctoral students that can be used as access to academic and student services;
5. A replacement KTM is issued in case the KTM is lost or damaged. The replacement KTM is published by the Bureau of Academic and Student Affairs.

CHAPTER XI. ACADEMIC CALENDAR

The academic calendar of UPN "Veteran" Jawa Timur was prepared by the Vice Rector for Academic Affairs which was authorized by the Rector as the basis for the preparation of the academic calendar at the Faculty and the schedule of academic activities by the study program. The function of the academic calendar as a guideline for the implementation of learning activities so that the learning process can take place effectively and efficiently;

The academic calendar is published 1 (one) time a year in the form of a Decree of the Rector of UPN "Veteran" Jawa Timur, and the academic calendar at least contains:

1. Registration period, selection exam, announcement of new student admission selection results;
2. Registration schedule (administrative and academic) for new students;
3. Schedule of initial activities for new students (Open Meeting of the Senate for New Student Admissions, and Introduction to New Student Campus Life / PKKMB);
4. Registration schedule for administrative and academic students of old students;
5. Lecture period;
6. Midterm Evaluation (ETS) and End of Semester Evaluation (EAS) Schedule;
7. KKN Schedule;
8. Final project / thesis examination period;
9. Judiciary and Graduation Schedule

CHAPTER XII. RULES FOR THE IMPLEMENTATION OF EDUCATION

Students are required to attend lectures and practicums on time until the time ends and not do things that can interfere with lectures and practicums

During lectures and practicum, students must:

- a. Be polite;
- b. Dress cleanly, neatly and modestly; and
- c. Shoed, unless not possible.
- d. Follow the provisions set during lectures and practicum.

During the course, students are prohibited from:

- a. Eating and smoking;
- b. Leave the lecture room/laboratory without the permission of the lecturer concerned; and
- c. Enable and/or use electronic devices, such as mobile phones and the like as well as music and game playing equipment, such as MP3s, iPods and the like, unless the use of electronic devices is part of the learning process.

Students are required to actively participate in learning at least 90% of scheduled academic activities. If students are absent from lectures due to participating in activities assigned and/or approved by the Rector or Faculty Leader, then their absence is not counted as alpha. Students who are absent from lectures due to illness, must show a doctor's letter and absence and are not counted as alpha. Students who do not attend other than because they participated in assignment activities from UPN "Veteran" Jawa Timur and because of illness, there must be an official certificate.

CHAPTER XIII. ACADEMIC VIOLATIONS AND SANCTIONS

13.1 Academic Misconduct

- 1) Misdemeanor academic offenses
 - a. Fraud and/or fraudulent acts;
 - b. Making noise/ making noise/ disrupting the learning process in the classroom/lab or exams, or not following the rules in class/lab;
 - c. Aid or attempted assistance of minor academic offenses (assisting intentionally or unintentionally to commit fraudulent acts);
 - d. Inclusion in misdemeanors (intentional or unintentional acts, cooperating or participating in or ordering to commit fraudulent acts and commotion in class).

- 2) Moderate academic misconduct
 - a. Jockeying in academic activities;
 - b. Repetition of moderate academic misconduct;
 - c. Moderate academic misconduct assistance or attempted assistance;
 - b. Inclusion/cooperation in moderate academic misconduct.

- 3) Gross academic violations
 - a. Plagiarism: is the act of intentionally or unintentionally obtaining or trying to obtain credit or value for a scientific work, by citing part or all of the work and / or scientific work of another party that is recognized as his scientific work, without stating the source precisely and adequately;
 - b. Forgery: is an act intentionally or unintentionally, without permission authorized to replace or change / falsify symbols (stamps), letterheads and / or instruments on correspondence in academic administration, names, signatures, grades or academic transcripts, diplomas, student identity cards, assignments, practicum reports, statements, or reports within the scope of academic activities;
 - c. Gratuity: is giving a gift or promise, while it is known or reasonably suspected that the gift or promise is given to move the lecturer or education staff to do or not do something in their position, which is contrary to their obligations;
 - d. Bribery: is the act of intentionally or unintentionally, influencing or attempting to influence another person by means of persuading, giving gifts or threats with the intention of influencing the assessment of his academic performance;
 - e. Insult: is the act of intentionally or unintentionally conveying words, writings or in any form that in principle degrades the dignity of fellow students, lecturers, administrative staff and

- officials within UPN "Veteran" Jawa Timur;
- f. Criminal offenses that are punishable by imprisonment of 1 (one) year or more based on applicable laws and regulations.
 - g. Repetition of moderate academic misconduct;
 - h. Gross administrative and disciplinary violations: are acts intentionally or unintentionally, either alone or in cooperation with acts that are contrary to the provisions of the rules and administration issued by the Ministry of Education and Culture of the Republic of Indonesia;
 - i. Assistance or attempted assistance of gross academic misconduct: is the act of intentionally or unintentionally, assisting or attempting to help provide facilities or infrastructure that may cause serious academic violations to occur;
 - j. Participation in gross academic offenses: is the act of intentionally or unintentionally, cooperating or participating in doing or ordering to commit acts that cause serious academic offenses to occur.

13.2 Sanctions Against Academic Misconduct

A. Sanctions against students

- 1) Sanctions for minor academic violations:
 - a. Stern warning verbally by lecturers/examination committees or in writing by faculty/study program leaders;
 - b. Expelled from lecture halls/halls, practicums or exams;
 - c. Reduction of test scores and / or statements of not passing in courses or academic activities carried out by the lecturer concerned whether at the request of the faculty leader / department head or not.
- 2) Sanctions for moderate academic violations
 - a. It is forbidden to participate in some academic activities;
 - b. Revoked the right / permission to participate in all academic activities temporarily by the leadership of UPN "Veteran" Jawa Timur for a maximum of 2 (two) semesters;
- 3) sanctions against gross academic violations
 - a. Canceled thesis or final project, or thesis;
 - b. Cancelled the exam and the exam results were given an E grade;
 - c. Expelled and removed his status as a UPN "Veteran" Jawa Timur student;
 - d. Reported/submitted to the authorities
- 4) Sanctions for alumni who are proven to have committed serious academic violations while studying at UPN "Veteran" Jawa Timur.
 - a. Revocation of diplomas, transcripts, and SKPI;

- b. Lost his right to continue his studies at UPN "Veteran" Jawa Timur.

Academic sanctions for moderate and severe violations are decided in a special meeting, namely at the meeting of the committee on conduct/ethics, Faculty Senate/University Senate.

- 5) Officials authorized to impose academic sanctions:
 - a. Lecturer/person in charge of the course or team/committee of examiners, for minor academic violations;
 - b. Study Program Coordinator for minor to moderate academic violations point 1;
 - c. Dean, for misdemeanors to moderate and gross academic misconduct items 1 and 2;
 - d. Rector, for minor academic offenses, moderate to severe.

13.3 Sanctions for Non-Academic Violations

- 1) Sanctions against students
 - a. Sanctions for minor academic violations:
 - 1. Stern warning verbally by lecturers/examination committees or in writing by faculty/study program leaders;
 - 2. Expelled from lecture halls/halls, practicums or exams;
 - 3. Reduction of test scores and / or statements of not passing in courses or academic activities carried out by the lecturer concerned whether at the request of the faculty leader / department head or not.
 - b. Sanctions for moderate academic violations
 - 1. It is forbidden to participate in some academic activities;
 - 2. Revoked the right / permission to participate in all academic activities temporarily by the leadership of UPN "Veteran" Jawa Timur for a maximum of 2 (two) semesters.
 - c. sanctions against gross academic violations
 - 1. Canceled thesis or final project, or thesis;
 - 2. Cancelled the exam and the exam results were given an E grade;
 - 3. Expelled and removed his status as a UPN "Veteran" Jawa Timur student;
 - 4. Reported/submitted to the authorities.
- 2) Sanctions for alumni who are proven to have committed serious academic violations while studying at UPN "Veteran" Jawa Timur.

- a. Revocation of diplomas, transcripts, and SKPI;
- b. Lost his right to continue his studies at UPN "Veteran" Jawa Timur.

Academic sanctions for moderate and severe violations are decided in a special meeting, namely at the meeting of the committee on conduct/ethics, Faculty Senate/University Senate.

- 3) Officials authorized to impose academic sanctions:
 - a. Lecturer/person in charge of the course or team/committee of examiners, for minor academic violations;
 - b. Study Program Coordinator for minor to moderate academic violations point 1;
 - c. Dean, for misdemeanors to moderate and gross academic misconduct items 1 and 2;
 - d. Rector, for minor academic offenses, moderate to severe.

13.4 Sanctions for Non-Academic Violations

- 1) The forms of sanctions for non-academic violations applied to students are as follows:
 - a. A written warning will be given if committing acts of violence, threats or other actions that can disrupt order and harm campus residents, carry out practical political activities and violate regulations set by the Faculty and University;
 - b. A suspension will be given in the form of a ban from participating in all academic activities for a certain period of time, for students who continue to carry out activities as listed in point a) above;
 - c. Will be dismissed as a University student if he commits an offense that damages the good name of the University, does not heed the suspension and or commits a criminal act based on a court decision that has definite legal force.
- 2) Sanctions for violations of a non-academic nature are decided in a special meeting (commission on rules / ethics, Faculty Senate / University Senate).

CHAPTER XIV. STUDENT CREDIT POINT UNIT (SKPM)

UPN "Veteran" establishes Student Credit Point Unit (SKPM) Regulations so that the implementation of student soft skill development programs through SKPM has a legal basis, so that supervisors/assistants/related units obtain guidance in assessing student activities; and so that the development of *students' soft skills* can be monitored gradually throughout the student's lecture period.

The objectives of SKPM Regulation in the context of developing *student soft skills* are:

- a. to instill a scientific attitude, stimulate creativity and innovation, improve the ability to research, write scientific papers, improve communication skills, and understanding of the profession;
- b. to improve health/fitness, achievement and cultural appreciation through the channeling of interests and talents in the arts and sports;
- c. to improve students' abilities in cooperation (teamwork, communication, management skills, spiritual, organizational and leadership as well as superior personality;
- d. to increase community service, a sense of concern for others, and instill a sense of love for the motherland;
- e. to improve competitive mentality / compete in national and international *scale events*; and
- f. to foster motivation and entrepreneurial spirit

The scope of SKPM is student activities in *soft skills development which* are attended by Bachelor Students (S1) at UPN "Veteran" Jawa Timur which are held at the levels of: Study Program / Department, Faculty, University, Regional / Province, National; and International.

The field of Student Activities consists of: Reasoning and Scientific Activities, Interest and Talent Activities, Social Care Activities, Organizational Activities and Leadership

Burden and Assessment SKPM takes into account the following:

1. SKPM load for students per semester at least 20 credit points;
2. Each student in the undergraduate program has a minimum load of 100 credit points to participate in UPN "Veteran" Jawa Timur Thematic KKN activities (regular KKN organized by LPPM) and 150 credit points to participate in the judiciary;
3. SKPM assessment based on the field of student activities consists of: Reasoning and Scientific Activities Interest and Talent Activities, Social Care Activities, Organizational and Leadership Activities, based on established rubrics, which are measured in student credit point unit values (SKPM);

4. The value of the credit point unit for each field of student activity is attached to the rubric of the student credit point unit which is an integral part of this rector's regulation;
5. SKPM evaluation is carried out every semester and the final results are expressed by letter grades and numerical values, as explained in Table 14.1.

6. SKPM evaluation results are published together with KHS;
7. SKPM achievements per semester are published in the form of credit points and cumulative SKPM achievements are published in the form of letter and numerical grades listed in the Certificate of Diploma Supplement (SKPI) document;
8. The cumulative SKPM Achievement Predicate is categorized as follows:
 - a. Enough, if the achievement of $2.00 \leq \text{SKPM} \leq 2.75$
 - b. Good, if the achievement of $2.76 \leq \text{SKPM} \leq 3.00$
 - c. Very good, if the achievement of $3.50 \leq \text{SKPM} \leq 3.75$
 - d. Special, if the achievement of $3.76 \leq \text{SKPM} \leq 4.0$

CHAPTER XV. OFF-CAMPUS LEARNING FOR UNDERGRADUATE PROGRAMS

MBKM activities are learning processes carried out outside the Study Program both within UPN "Veteran" Jawa Timur and outside UPN "Veteran" Jawa Timur which consists of:

- a. learning in other Study Programs within UPN "Veteran" Jawa Timur;
- b. learning in the same Study Program at universities outside UPN "Veteran" Jawa Timur;
- c. learning in other Study Programs at universities outside UPN "Veteran" Jawa Timur; and
- d. learning at non-tertiary institutions.

The scope of MBKM activities is 9 (nine) learning activities which include:

- a. Internship/Work Practice;
- b. Building Villages/Thematic Community Engagement Courses;
- c. Student Exchange;
- d. Humanitarian Projects;
- e. Research;
- f. Entrepreneurial Activities;
- g. Independent Study/Project; and
- h. Teaching Assistance in Education Units.
- i. Defend the Country.

Village Building Activities / Thematic Community Engagement Courses, Humanitarian Projects and Teaching Assistance in Education Units can be realized through community service activities
Implementation of MBKM learning activities by taking into account the following:

- a. The maximum number of credits that can be taken in the context of implementing MBKM activities is 20 credits and the maximum number is 40 credits.
- b. MBKM activities can only be carried out by:
 - Universities that have a rank equivalent to or higher than UPN "Veteran" Jawa Timur,
 - Universities that have an MoU with UPN "Veteran" Jawa Timur; or
 - Non-tertiary institutions that have an MoU with UPN "Veteran" Jawa Timur.
- c. MBKM activities on and off campus are carried out in the form of online, offline or a combination of both.
- d. MBKM activities on campus are carried out in the form of student

exchanges / lectures between study programs at UPN "Veteran" Jawa Timur.

- e. MBKM activities are planned and included in the student's Study Plan (KRS) and reported the results on the Study Results Card (KHS) and published in the Higher Education Database (PDDikti).
- f. Planning for taking MBKM activities by students is carried out with direction from academic supervisors and approved by the Study Program Coordinator.
- g. MBKM activities carried out outside the campus are accompanied by MBKM assistant lecturers assigned by the Rector/Dean.
- h. Students who take MBKM activities are stipulated in the Decree of the Rector/Dean
- i. Recognition of MBKM learning outcomes is carried out through credit transfer to courses that are already available in the study program curriculum or as new courses included in the study program curriculum.
- j. The value and weight of credits of MBKM learning outcomes on courses are based on suitability:
 - a. Graduate Learning Outcomes (CPL) or Course Learning Outcomes (CPMK) of at least 80% for recognition to the Core Courses of the Study Program.
 - b. Hours of learning activities with credits, which is 1 credit equivalent to 170 minutes / week / semester or 2720 minutes / semester or 45 hours / semester.
- k. Learning activities outside the study program that are equalized have a minimum learning load equivalent to 1 (one) credit.
- l. Calculation of credit weight by taking into account the inputs, processes, and outputs of MBKM learning described in the technical instructions for MBKM activities.

CHAPTER XVI FACULTY OF ECONOMICS AND BUSINESS

History of the Faculty of Economics and Business

The Faculty of Economics and Business (FEB) is one of the forerunners of the Faculty within the Universitas Pembangunan Nasional "Veteran" Jawa Timur (UPNVJT). Based on the Rector's Letter dated April 4, 1993, the name of the Faculty of Economics (FE) has been changed to FEB. At the beginning of its establishment, it only had two majors, namely General Economics and Corporate Economics, referring to the Decree of the Minister of Veterans and Demobilization No: 133 / KPTS / 1965 dated March 21, 1965 and No. 140 / KPTS / 1965 TMT, which at that time was under the auspices of the Veterans National Development Academy (APNV) and since August 1, 1965 has increased its status to a University and since then it has become a National Development College (PTPN). Furthermore, along with the development of the world of education and market needs, it changed to UPNVJT and since October 7, 2014 and its status has changed to State University (PTN) with Institutional Accreditation B. FEB until now has five Study Programs (PS), namely Development Economics Study Program (EP) with Accreditation A, Management Study Program with Accreditation A, and Accounting Study Program with Accreditation A. S2 Study Program, Master of Management and Master of Accounting, both accredited B. History has recorded the name of the Dean of the Faculty of Economics who first served was Lt. Col. Umar Usman BA, was appointed based on the Rector's Decree No. 11/Rek/Kpts/PTPN/1968 dated September 5, 1968.

Next are the names of his successor Dean and SK. In 1969 the position of Dean was held by Drs.Ec. Armyn Rangkuti, based on Rector's Decree No. 021/Rek/Kpts/PTPN/1969 on June 20, 1969. Furthermore, in 1969 the Coordinating Dean Order No. 045/SP/Dekor/PTPN/69 was also issued, to appoint Drs. Djamil Idris as Dean of the Faculty of Economics. On April 21, 1973, the new Dean was appointed, Drs.Ec. A. Muslim Hamzen. Based on the Rector's Decree No. Skep/21/Rek/B.2/V76 dated May 21, 1976, Drs.Ec have been appointed. Tukiran S. Donoatmodjo as Dean of the Faculty of Economics with Secretary Drs.Ec. Migfar Siradj and as General Economic Kajur are Drs.Ec. Muljanto and Kajur Ek. The company is Drs.Ec. Soeparlan Pranoto.

a. Vision

Become a Faculty of Economics and Business that excels in the character of State Defense.

b. Mission

Based on the Vision & Mission of FEB UPNVJT in phase II of the 2020-2024 period are as follows:

1. Developing higher education based on fighting values to produce graduates who have competence in the fields of economics, management, and accounting ;
2. Improving the culture of research in economics, management and accounting in the development of science and technology that is useful for the welfare of society;
3. Organizing community service in the fields of economics, management, and accounting based on research and local wisdom;
4. Organizing good and clean governance in order to achieve accountability for budget management;
5. Developing the quality of superior human resources in attitudes and values, performance, mastery of knowledge, and managerial;
6. Improve the integrated facilities and infrastructure management system;
7. Increase institutional cooperation in economics, management, and accounting with *stakeholders* both at home and abroad.

c. Purpose

Based on the mission mentioned above, the goals to be achieved by FEB UPNVJT in 2020-2024 were formulated. The objectives are as follows:

1. The realization of the implementation of curriculum and educational services relevant to the Indonesian National Qualifications Framework (KKNI) based on state defense, in the fields of economics, management, and accounting.
2. Achieving quality and innovation of research in the fields of economics, management and accounting and providing benefits for improving public welfare.
3. The realization of community service activities that are research-based and have the character of State Defense.
4. Achieving the quality of graduates with State Defense character and have competitive competencies in the fields of economics, management, and accounting.

Goal

Based on Law of the Republic of Indonesia Number 12 of 2012 concerning Higher Education and Government Regulation of the Republic of Indonesia Number 04 of 2014 concerning the Implementation of Higher Education and Management of Higher Education, the targets of FEB UPNVJT in Phase II for the period 2020 - 2024 include the fields of education and teaching, the fields of research and community

service, the field of organization, the field of finance, the field of Human Resources (HR), the field of facilities and infrastructure, as well as the field of Cooperation. Based on the description above, the targets are divided into 7 (seven) areas including:

- 1) Education and Teaching
 - Producing competent graduates with State Defense character in the fields of economics, management, accounting, and have competitive abilities in accordance with *stakeholder needs*.
- 2) Field of Research and Community Service
 - Improve the intellectual ability of educators as researchers in producing superior research in the fields of Management, Accounting, Economics, and Community Economic Empowerment with a martial character;
 - Produce research products oriented to innovation, problem solving, and science development with national, and international publications and IPR; Increased research-based community service activities for problem solving and empowerment in the community.
- 3) Field of Organization
 - Achieving organizational governance and establishing good partnerships by supporting the implementation of higher education autonomy.
 - Achieving good management of the Tridarma of Higher Education.
- 4) Finance
 - Increased sources of income for institutional development;
 - Increased accountability, capability, and efficiency of financial management.
- 5) HR (Human Resources)
 - The availability of human resources with the character of State Defense and having the competence to support the Tridarma of Higher Education program.
 - The availability of an HR management system in supporting the activities of the Tridarma of Higher Education.
- 6) Facilities and Infrastructure
 - The availability of adequate facilities and infrastructure to support the activities of Tridarma and its supporters;
 - The availability of an effective, efficient, and productivity-supporting infrastructure management system.
- 7) Field of Cooperation
 - Achieving institutional cooperation with *stakeholders* both at home and abroad that is intensive and benefits both parties.

Policy and Development Direction

In line with UPNVJT's vision, the Strategic Policy for National Development of Science and Technology (Jakstranas Iptek) 2005 - 2025, the Strategic Plan of the Ministry of Education and Culture for 2020-2024 which includes: (1) increasing relevance and competitiveness, (2) improving governance, (3) equitable access, and (4) improving quality, the policy direction and development of FEB UPNVJT are determined as follows.

A. Education and Teaching

- Producing graduates who are experts in the fields of economics, management, and accounting with competent and competitive qualifications and State Defense character in accordance with the needs of *stakeholders* relevant to national higher education standards (SNPT) and future world needs;
- Organizing educational programs on the basis of *Student Centered Learning* (SCL) and supporting the implementation of the KKNI curriculum with state defense characteristics in the fields of economics, management, and accounting.

b) Research Fields

- Improving the culture of research with the character of defending the state in the fields of economics, management, and accounting that provides benefits to the needs of the user community;
- Improve the academic atmosphere based on research and community service;
- Organizing productive and published research programs on a national, accredited and international scale and having IPR.

c) Field of Community Service

In semester three (3), students have to prepare a proposal to do PKL with a weight of one (1) credit. In semester four (4) students carry out the thesis writing process with a weight of six (6) credits and are given the opportunity to repeat courses that have not graduated in semesters one, two, and three (1, 2 and 3).

CHAPTER XVII. FACULTY OF AGRICULTURE

History of development

Faculty of Agriculture, Universitas Pembangunan Nasional "Veteran" Jawa Timur is one of the higher education institutions in agriculture in Indonesia which was established on May 17, 1968. Over a period of 45 years, UPN "Veteran" Jawa Timur has undergone various status changes, namely;

- a. At May 17, 1968 was the milestone of the establishment of the Faculty of Agriculture, National Development College (PTPN) "Veteran" Jawa Timur Branch which was marked by the issuance of the Decree of the Ministry of Transmigration, Veterans and Demobilization No. 062 / Kpts / Mentransved / 68 and the Decree of the Rector of PTPN "Veteran" Yogyakarta. No. 11/Rek/kpts/ PTPN/68 dated September 5, 1968.
- b. In the period 1976-1982, PTPN "Veteran" Jawa Timur Branch was under the direct auspices of the Ministry of Defense / Pangab after during the period 1966 to 1976 under the auspices of the Ministry of Transmigration, Veterans and Demobilization with the status of PTPN "Veteran" Jawa Timur Branch as **Official College**. Furthermore, in the period 1983-1994 the status of development was directly under the guidance of the Directorate General of Persmanvet of the Ministry of Defense of the Republic of Indonesia, and in 1994 until now under the guidance of the Sudirman Great Commander Struggle Foundation (YKPBS).
- c. In 1977 there was a change in the name of PTPN "Veteran" Jawa Timur Branch to Universitas Pembangunan Nasional "Veteran" Jawa Timur Branch
- d. The period 1966 – 1993 was under coordination with UPN "Veteran" Yogyakarta, then in 1993/1994 it was independent; and since November 29, 1994 the Faculty of Agriculture obtained **private status equated as a consequence of the** status of PTS UPN "Veteran" Jawa Timur based on the Joint Decree of the Minister of Education and Culture-Minister of Defense Number: 0307 / O / 1994 - Kep / 10 / XI / 1994.
- e. From November 1994 to August 10, 1998, the Faculty of Agriculture UPN "Veteran" Jawa Timur prepared for higher education accreditation status; and based on the decree of the National Accreditation Board for Higher Education No. 001 / BAN-PT / Ak-1 / VIII / 1998 dated August 11, 1998 has obtained **full accredited status** for all Departments / Study Programs.
- f. From 1998 to 2007 the status of all Study Programs (Prodi) at the Faculty of Agriculture (4 Study Programs, namely: Plant Disease Pests, Soil Science, Agronomy, and Agricultural Socioeconomics) based on assessments from the National Accreditation Board for Higher Education have all been accredited with a B grade.

- g. **Based on the Decree of the Director General of Higher Education** Number: 163 / **DIKTI** / Kep / 2007 Date: November 29, 2007, concerning the arrangement of the Faculty of Agriculture Study Program, the Faculty of Agriculture which was originally 4 (four) Study Programs became 2 (two) Study Programs, namely the Agrotechnology Study Program Number: **972 / SK / BAN-PT / Akred / S / IX / 2015**. BAN PT Prodi Agribisnis No 1145/SK/BAN-PT/Akred/S/XI/2015, BAN PT MAGISTER Manajemen Agribisnis No.146 /SK/BAN-PT/Akred/M/V/2014.
- h. As of October 6, 2014, the Universitas Pembangunan Nasional "Veteran" Jawa Timur which was originally under the Education and Housing Welfare Foundation with the status of a Private University became a State University with Presidential Regulation number 122 of 2014 consisting of 7 Faculties with 19 undergraduate study programs (S1) and 3 strata 2 (S2) study programs under the guidance of the Ministry of Research, Technology and Higher Education with the characteristics of belanegara.

CHAPTER XVIII. FACULTY OF ENGINEERING

History of the Faculty of Engineering

Universitas Pembangunan Nasional Veteran Jawa Timur (UPNVJT) was established on July 5, 1959 under the name Akademi Administrasi Pembangunan Veteran (AAPV). From July 1959 to 1965 AAPV Surabaya Branch changed its name to Veteran National Development College (PTPN). On May 17, 1968 PTPN Veteran Jawa Timur Branch with 3 Faculties, namely: Faculty of Economics, Faculty of Industrial Technology was originally named the Faculty of Chemical Engineering, established on May 17, 1968, based on the Decree of the Ministry of Transmigration, Veterans Affairs and Demobilization Number 062 / Kpts / MENTRANVED / 68. In 1989, the Faculty of Chemical Engineering changed to the Faculty of Industrial Technology with two Study Programs, namely the Chemical Engineering Study Program and the Industrial Management Engineering Study Program;

Along with the need for experts in the field of food industry and Information Technology, in 1993 the Faculty of Industrial Technology opened a Food Technology Study Program and in 2002 opened an Informatics Engineering Study Program;

Since its establishment in 1968 until T.A. 1994/1995, the Faculty of Industrial Technology had the status of State Service under the Ministry of Defense and Security. FTI has 3 (three) Study Programs (PS), namely: 1) Chemical Engineering Study Program (TK), Study Program establishment decree: May 17, 1968, BAN-PT Decree Number: 027/BAN-PT/AK-XII/S1/IX/2009, dated September 11, 2009. 2) Industrial Engineering (IT) Study Program, Study Program establishment decree: November 29, 1994, BAN-PT SK Number: 032/BAN-PT/AK-XII/S1/XIII/2010. 3) Food Technology Study Program (TP), Study Program establishment decree: November 29, 1994, BAN-PT SK Number: Ministry of National Education of the Republic of Indonesia No. 08288/AK-IX-SI-028/UPILLA/I/2006. Since November 29, 1994, based on the Joint Decree of the Minister of Education and Culture No: 0307 / O / 1994 and the Minister of Defense No: Kep / 10 / XI / 1994 concerning the status of UPNVJT from the Official State changed its status to Private Universities (PTS). 4) Informatics Engineering Study Program, Study Program establishment decree: July 9, 2003, BAN-PT Decree Number: 019/BAN-PT/AK-X/S1/VIII/2007. 5) Information Systems Study Program, Study Program establishment decree: August 10, 2007, BAN-PT Decree Number: 010/BAN-PT/AK-XIV/S1/VII/2011;

On October 6, 2014 the Universitas Pembangunan Nasional "Veteran" Jawa Timur which was originally under the Education and Housing Welfare Foundation with the status of a Private University was returned to a State University with Presidential Regulation Number 122 of 2014 consisting of 7 Faculties with 19 Strata 1 (S1) Study Programs and 3 Strata 2 (S2) Study Programs under the

guidance of the Ministry of Research, Technology and Higher Education of the Republic of Indonesia with the characteristics of statehood;

On August 23, 2016 based on the Regulation of the Minister of Research, Technology and Higher Education No. 38 of 2015, the Faculty of Industrial Technology (FTI) changed to the Faculty of Engineering (FT);

The Faculty of Engineering until now organizes strata-1 (S-1) education programs consisting of 6 (six) Study Programs, namely the Chemical Engineering Study Program, Industrial Engineering Study Program, Food Technology Study Program, Environmental Engineering Study Program, Civil Engineering Study Program, and Mechanical Engineering Study Program. The Faculty of Engineering also organizes a strata-2 (S-2) education program, namely the Master of Environmental Science Study Program.

1. Chemical Engineering Study Program

The Chemical Engineering Study Program, Faculty of Engineering UPN "Veteran" Jawa Timur has been carrying out lecture activities since 1968, in 2015 it received an accreditation rating with an A grade from BAN-PT. Until now, it has graduated thousands of Chemical Engineering graduates who work in various agencies both in government and private agencies.

2. Industrial Engineering Study Program

The Industrial Engineering Study Program, Faculty of Engineering UPN "Veteran" Jawa Timur, established in 1990, has been accredited by BAN-PT in 2010 with a grade of B. Until now, the IT Study Program has graduated thousands of Industrial Engineering graduates who are absorbed in various fields, in government and private institutions.

3. Food Technology Study Program

The Food Technology Study Program, Faculty of Engineering UPN "Veteran" Jawa Timur was established in 1993. In 2016 the Food Technology Study Program has been accredited with an Accreditation value of B and until now has graduated a bachelor of Food Technology. Its graduates are needed both now and in the future, especially in supporting developments in the food industry.

4. Civil Engineering Study Program

The Civil Engineering Study Program, Faculty of Engineering UPN "Veteran" Jawa Timur was established in 1993, has been accredited and in 2015 received an accreditation rating of B. The purpose of Civil Engineering education is to produce competent Bachelor in engineering and design with State Defense character and able to compete in the global era.

5. Environmental Engineering Study Program

The Environmental Engineering Study Program, Faculty of Engineering UPN "Veteran" Jawa Timur was established in 1993, has been accredited in 2013 with an A grade aimed at producing qualified and professional Bachelor in the

field of environmental engineering in accordance with the needs of graduate users.

6. Mechanical Engineering Study Program

The Mechanical Engineering Study Program is a new study program, which was opened in 2020 after obtaining permission from the Minister of Education and Culture through Skep Number: 858 / M / 2020 dated September 15, 2020. This study program aims to produce graduates who have strong basic engineering knowledge so that they are able to design, make, use, and manage machines and systems related to machinery. The field of Mechanical Engineering operates at the frontier of knowledge of science and engineering, exploring various applications of science ranging from energy conversion, design, manufacturing to metallurgy. This science studies physical principles which are then implemented in the analysis, design, manufacturing, and maintenance of machines. Therefore, students must deepen their abilities in several branches of science such as mechanics, kinematics, materials engineering, and thermodynamics.

7. Physics Study Program

The Physics study program was established to strengthen the science foundation within UPN Veteran Jawa Timur. At the beginning of the establishment of the Physics Study Program was under the auspices of the Faculty of Engineering. The UPN "Veteran" Jawa Timur Physics Study Program was compiled by seven lecturers based on the decree of the Dean of the Faculty of Engineering number NUMBER: 64 /UN63.3/TU/2021. The study program establishment form was uploaded on May 11, 2022. And decree Number 6443/SK/BAN-PT/Ak.P/S/IX/2022 concerning the Accreditation rating of the Physics Study Program at the Undergraduate Program of the National Development University has come down on July 13, 2022. Based on the decision of the Director of the Executive Board of the National Accreditation Board for Higher Education which establishes the Physics Study Program at the Undergraduate Program of the Universitas Pembangunan Nasional Veteran Jawa Timur, Surabaya City, it meets the requirements for the GOOD Accreditation Rating. To accommodate the development of Physics and its application, the Physics Study Program develops 4 (four) groups of areas of interest, namely Material Physics, Instrumentation Physics, Medical Physics, and Optical Physics.

8. Environmental Science Study Program

The UPN "Veteran" Jawa Timur Environmental Science Master Program was established in 2017 as outlined in the Study Program Decree No. 281/M/KPT/I/2017 dated May 29, 2017 concerning the Permit to Open the Environmental Science Study Program Master Program at the Universitas Pembangunan Nasional "Veteran" Jawa Timur

a. Vision

"To Become a Superior Faculty of Engineering with State Defense Character".

b. Mission

The mission of the Faculty of Engineering UPN "Veteran" Jawa Timur, namely:

18.2 Industrial Engineering Study Program

The Industrial Engineering Study Program (Progdi IT) of the Faculty of Engineering UPN "Veteran" Jawa Timur was established in 1990 with the status of Official State. In 1994, with a joint decree of the Minister of Defense and Minister of Education and Culture Number: Kep / 0307 / U / 1994, its status changed to **Private "Disamakan"**. In 2001 the IT Study Program for the first time applied for accreditation to BAN-PT Dirjen DIKTI and obtained Accredited Status **with a C grade** (Basically, BAN-PT Decree Number: 04662-Ak-V-S1-002 UPITKI-III-2002). In 2005 he applied for reaccreditation to BAN-PT Dirjen DIKTI, obtained Accredited Status **with Value B** based on BAN-PT Decree Number: 07251 / Ak-IX-S1-015 / UPITKIVIII / 2005. In 2010 applying for reaccreditation to BAN-PT Dirjen Dikti obtained Accredited status **with a grade of B**. Based on BAN-PT Decree Number: 032/BAN-PT/AK-XIII/S1/XII/2010, dated December 23, 2010. In 2015, applying for Reaccreditation to BAN-PT obtained **an accreditation value of B**, based on the Letter of Deputy BAN-PT, Number: 1011/SK/BAN-PT/Akred/S/IX/2015,

The discipline of Industrial Engineering is to study and study how to design, install, operate, and improve integral (integrated) systems that

include humans, machines, materials, energy and information. What is meant by integral systems is not only industrial systems, but all systems that have components of humans, machines, materials, energy and information. The main objective of designing and improving integral systems is the achievement of integral system performance that has high productivity and quality. This shows that the advantage of the Industrial Engineering discipline is that it has a wide scope of material, and the perspective and efforts to overcome problems are carried out systemically. With these advantages, Industrial Engineering graduates have strong competencies to work in all fields, both manufacturing and service industries, and also in government.

a. Vision

Become an Industrial Engineering study program that excels in the application of science and technology in the field of Industrial Engineering which has the character of State Defense in 2024.

b. Mission

1. Organizing quality education in the field of manufacturing system design and industrial management with the character of State Defense;

The basis for establishment is based on the Rector's Decree No. SKEP / 254 / VII / 1993 and ratified by the Decree of the Minister of Education and Culture of the Republic of Indonesia and the Minister of Defense of the Republic of Indonesia Number: Kep / 0307 / U / 1994 – 10 / XI / 1994 dated November 29, 1994;

In 1995, the Food Technology Study Program obtained registered status based on the Decree of the Director General of Higher Education of the Ministry of Education and Culture No. 024 / Dikti / Kep / 1995 and based on the Decree of BAN – PT Depdiknas RI NO. 0444 / AK-I-III-033 / UPNPA / XI / 2000 dated November 23, 2000 the Food Technology Study Program has been accredited (B). Since January 26, 2006, based on the Decree of BAN-PT Depdiknas RI No. 028/BAN-PT/Ak-IX/S1/I/2006, Food Technology Study Program has been accredited (A) for 5 years from the date stipulated. Since January 21, 2008 with No. 355 / D / T / 2008 the Food Technology Study Program has received an extension of operational licenses under the Faculty of Industrial Technology. In 2011 it has obtained an operational permit from BAN PT, In 2016 the Food Technology Study Program with an Accreditation value of B.

This program has a cumulative study load of at least 146 credits with a standard cumulative study duration, 8 to 14 semesters. The scientific specifications provided include understanding agricultural products as biological materials, knowledge of the main types of processes in converting biological materials into commodities, knowledge of processing tools and machinery, the ability to discuss problems with aspects of

commodity processing, the ability to perform process engineering for new products and how to operate processing units as systems and optimization.

The increase in environmental problems, both in intensity and magnitude, requires inadequate handling by practitioners. Such conditions, require a more specific scientific approach with a higher level. So it is necessary to develop study programs in universities that have expertise programs in the field of Environmental Engineering. In essence, the prevention of environmental damage can be approached with an engineering approach, environmental control, and environmental management.

Both fields were developed at the Universitas Pembangunan Nasional "Veteran" Jawa Timur at this time. The Environmental Engineering study program of UPN "Veteran" Jawa Timur, was established in 1993 with the status of STATE SERVICE under the management of the Ministry of Defense and Security. In its development based on the joint decree of the Minister of Education and Culture No: Kep / 0307 / X / 1994 and Menhankam No : Kep / 10 / XI / 1994 the status of the Environmental Engineering study program became private was equalized and changed to the Study Program in 2009. In 2002 and 2007 based on the decree of BAN-PT. Director General of Higher Education Ministry of National Education Number: 04663 / Ak-V-S1-002 / UPITPL / III / 2002 and Number: 016 / BAN-PT / Ak-X / S1 / VIII / 2007, obtained Accreditation B while in 2013 based on the SK BAN-PT. Director General of Higher Education of the Ministry of National Education Number: 010 / BAN-PT / Ak-XV / S / I / 2013 Environmental Engineering Study Program successfully obtained an Accreditation score of A.

a. Vision

Become a superior Environmental Engineering Study Program capable of mastering, applying and developing science and technology in the field of Environmental Engineering and Management with the character of State Defense in 2024.

b. Mission

In an effort to realize this vision, the Mechanical Engineering Study Program has a mission:

CHAPTER XIX. FACULTY OF SOCIAL AND POLITICAL SCIENCES

The existence of the Faculty of Social and Political Sciences began with the establishment of the Faculty of Administrative Sciences since 1993. This faculty has two departments, namely the Department of State Administration and Commercial Administration. One year later, the Faculty of Administrative Sciences opened a new department, namely the Department of Communication Science in the 1994/1995 Academic Year. In further developments, the Decree of the Rector of UPN "Veteran" Jawa Timur Number: Skep / 101 / IX / 2005 dated May 6, 2005 concerning the Change of Name of the Faculty of Administrative Sciences UPN "Veteran" Jawa Timur to the Faculty of Social and Political Sciences. Furthermore, the status of UPN "Veteran" which originally had the status of an Official College changed to a Private University under Kopertis Region VII in accordance with the Joint Decree between the Minister of Defense and the Minister of Education and Culture number: 0307/0/1995 KEP/10/XI/1995 dated November 29, 1995 concerning Increasing Service of UPN "Veteran" through the Implementation of Linkage and Integrated.

Further development of the existence of the Faculty of Social and Political Sciences occurred in the 2009/2010 academic year by adding a new Study Program, namely International Relations. In 2020 there was the addition of a new Study Program, namely Tourism. Thus the Faculty of Social and Political Sciences has five Study Programs, namely:

1. Public Administration
2. Business Administration.
3. Communication Studies.
4. International Relations
5. Tourism

Based on Presidential Regulation No. 122 of 2014 dated October 6, 2014 concerning the Establishment of the Universitas Pembangunan Nasional "Veteran" Jawa Timur, the status of the Universitas Pembangunan Nasional "Veteran" Jawa Timur changed from a Private University to a State University under the Ministry of Research, Technology and Higher Education.

CHAPTER XX. FACULTY OF ARCHITECTURE AND DESIGN

Faculty of Architecture and Design (FAD) is one of 7 (seven) faculties at UPN "Veteran" Jawa Timur which has 2 (two) study programs, namely the Architecture Study Program and the Visual Communication Design Study Program. Initially, the Faculty of Architecture and Design was a fraction of several study programs at the Faculty of Civil Engineering and Planning (FTSP) which had 4 (four) study programs, namely Architectural Engineering, Environmental Engineering, Civil Engineering and Visual Communication Design. And since August 2016 through the Decree of the Rector of UPN "Veteran" Jawa Timur Number: 153 / UN63 / KP / 2016 then the Faculty of Civil Engineering and Planning (FTSP) was closed with the establishment of the Faculty of Architecture and Design as a new faculty with the Architecture Study Program and Visual Communication Design Study Program. While 2 (two) other study programs, namely Environmental Engineering and Civil Engineering, are included in the Faculty of Engineering.

CHAPTER XXI. FACULTY OF LAW

Faculty of Law (FH) as a young faculty within UPN "Veteran" Jawa Timur. Since October 6, 2014, UPN "Vreeran" Jawa Timur changed its status to become a State University under the Ministry of Research, Technology and Higher Education of the Republic of Indonesia. The Education Program managed by the Bachelor of Undergraduate (S1) program with its operational Law Study Program officially began since the issuance of a permit from the Directorate General of Higher Education of the Ministry of National Education No.183 / D / T / 2007 dated January 30, 2007 concerning the implementation of S1 Higher Education in Law at the Universitas Pembangunan Nasional "Veteran" Jawa Timur then set as the birthday of the Faculty of Law UPN "Veteran" Jawa Timur. Regarding lecture activities, it was initially carried out in the Giri Pustaka building before occupying its own building. Since July 7, 2007 which was marked by the inauguration of the Giri Satya Building (has 3 floors) by the Secretary General of the Indonesian Ministry of Defense, the Faculty of Law has had its own building. Thus, all lecture and academic activities of the faculty are centralized in the Giri Satya Building. In order to realize the implementation of the education and teaching process that has the same direction, movement and goals, it is deemed necessary to compile and publish the FY 2017/2018 Academic Guidebook for new students and the academic community of the UPN "Veteran" Jawa Timur Faculty of Law.

a. History of the Faculty of Law

The establishment of the Faculty of Law within UPN "Veteran" Jawa Timur was originally an initiative of the Rector of UPN "Veteran" Jawa Timur which at that time was held by Brigadier General. (Ret.) Suparyo Sri Indranto, M.Pkn. This idea was followed up by preparing human resources by sending Sutrisno, SH to the Stata dua (S2) level with the hope that in the future they will have competent and qualified lecturers to be able to manage the Law study program.

In 2001, the Survey Team consisting of Haryo Sulistiyantoro, SH., P. Handoko, S.Sos., SH., Ir. Jusuf Mahdi., Sutrisno, SH., and Subani, SH., M.Si., found facts that showed a positive trend of public interest in Legal Higher Education. The follow-up to the results of the survey, then by the team was formulated and submitted in a master proposal for the establishment of a New Faculty, but at that time it could not be approved by the Head of UPN "Veteran" Jawa Timur and BPH UPN "Veteran" Jawa Timur because the human resources owned at that time were considered insufficient.

On April ±, 10, 2006, Mr. Rector Maj. Gen. (Ret.) Drs. H. Warsito. SH., MM and Assistant Rector I ordered Sdr Sutrisno, SH, M.Hum accompanied by Sdr Hariyo Sulistiyantoro, SH, to explain the plan for the establishment of the Law

Study Program on April 12, 2006 before the senate of UPN "Veteran" University of Jawa Timur, Alhamdulillah the University Senate approved the plan to establish the Faculty of Law at UPN "Veteran" Jawa Timur. Furthermore, legally formally issued a Rector's Order Number: SPRINT / 296 / VIII / 2006 concerning the Establishment of Organizational Structures and Positions at the Faculty of Law UPN "Veteran" Jawa Timur. The culmination was on September 4, 2006 in an Open Senate Meeting which was attended by all University Leaders, Faculty Leaders, new students and all parents of new students, the Chairman of BP UPN "Veteran" YKBPS beat the gong to mark the inauguration of the establishment of the Faculty of Law UPN "Veteran" Jawa Timur as well as symbolically pinning pins to the first batch of student representatives of the Faculty of Law totaling 96 people.

The vital role of lecture building infrastructure and several supporting facilities for a higher education institution was immediately followed up by the Head of UPN "Veteran" Jawa Timur by issuing Skep No.39 / XI / 2006 / YKBPS by the Sudirman Great Commander Championships Foundation under the guidance of the Indonesian Ministry of Defense approved the plan for the construction of the Faculty of Law building consisting of 3 floors complete with facilities. The construction of the Faculty of Law building is located on the south ring road of the UPN "Veteran" Jawa Timur campus facing south with a target of completion before the new academic year 2007/2008. Thus, during the new academic year, the new building of the Faculty of Law can already be used by students.

The commitment to create quality graduates of the Faculty of Law was realized by the Rector of UPN "Veteran" Jawa Timur with the establishment of Pusbankum (Center for Development Studies and Legal Advocates) UPN Veteran Jawa Timur. This Pusbankum was formed as part of the Faculty of Law student laboratory to provide legal services for the UPN Academic Community and the Community who need legal assistance and consultation. Pusbankum in its implementation involves the active participation of Faculty of Law students with the guidance of Faculty of Law lecturers. This is where the role of students is to provide legal assistance and consultation to the community to hone and sharpen the value of student expertise in the implementation of the Tri Dharma of Higher Education. In addition to the main facilities of lecture halls, the construction of the Faculty of Law building is equipped with other supporting facilities, namely moot court laboratory rooms consisting of civil and criminal courts, religious courts, TUN courts and so on that are tailored to needs. In addition, the Faculty of Law is equipped with student service rooms, reading rooms, quality assurance rooms, BEM and BLM Faculty of Law.

The head of the Faculty of Law for the first time the Dean was concurrently held by the Rector of UPN "Veteran" Jawa Timur, Maj. Gen. (Ret.) Drs. H.

Warsito. SH., MM., Kaprogdi Sutrisno, SH, M.Hum, Head of TU Peni, SH Tauikid executor and then Acting Dean Drs. Ec. Khusnul Hadi, SH. MS., assisted by Assistant Dean Haryo Sulistiyantoro, SH., Head of Law Sutrisno, SH. M.Hum., and Head of Progdi P. Handoko, S.Sos.SH., MM. From 2008 to 2016 the Faculty of Law was led by Hariyo Sulistiyantoro as dean. From 2016 until now the Faculty of Law is led by Dr. H. Sutrisno. S.H., M.Hum

So that the goals of the teaching and learning process can be achieved and create students of the UPN "Veteran" Jawa Timur Informatics Engineering Department who are undergraduate graduates who are useful for the surrounding community.

It is evident from the many positive responses from new students and students who increase every year, becoming the study program that has the most students.
